 - Going back to being more conservative with revenue projections in response to being too optimistic in past couple years. Revenue is behind.
 - Transit, complete streets, child care and admin are the major areas
 - Last year expected \$15M and have \$37M
 - A lot of the projects not funded for the next 5 years. Projects haven't been well defined yet.
 - Buchanan Street Malls is the highest priority for SFMTA
 - This will come back to us in the fall and November for feedback and approval
 - i. Ted asks: would it help to prioritize the items in each category?
 - 1. SFMTA and Public Works will speak with us
 - ii. Robin: questions greening budget
 - Categories were consolidated, Complete Streets includes Greening
 - iii. Status of 21 Hayes and 6 Parnassus, funding for Haight Octavia intersection congestion, study removal of remaining Central freeway
