13 Section 1. Findings.

14 (a) Pursuant to Planning Code Section 302, this Board of Supervisors finds that this  
15 Ordinance will serve the public necessity, convenience, and welfare for the reasons set forth  
16 in Planning Commission Resolution No. 17778, and incorporates those reasons herein by  
17 reference. A copy of said Planning Commission Resolution is on file with the Clerk of the  
18 Board of Supervisors in File No. 090178.

19 (b) The Board of Supervisors finds that this Ordinance is, on balance, consistent with the  
20 General Plan and the Priority Policies of Planning Code Section 101.1(b) for the reasons set  
21 forth in Planning Commission Resolution No. 17778, and incorporates those reasons herein  
22 by reference.

23 (c) In accordance with the actions contemplated herein, this Board adopted Ordinance No.


